Just some of the highlights of what's going on around us, At the NHS queues are getting longer, more boats are crossing the channel and lives that are being lost in pursuit of a 'better life'. Brothers of Province41 have been made aware of those going through end-of-life in hospices, not least in North London

Hospice the Provincial Project for which councils are being urged to fundraise. I am also aware that several other councils have got their own council fundraising for a project of their choice. My council are fundraising for WaterAid to help those people who lack the gift of clean running water to cook, bathe and clean their homes; that is if they do have a home at all. What comes to mind is how many easily forgo to meditate on how lucky we are in spite of British austerity, cost of living, homelessness, illness etc. It is so easy for one to consider one's own discomforts and but fail to look at others who may be battling with real difficulties in life. This is a reminder to all of our three hundred and seventy brothers in Province of our opportunities to help those really in need by fundraising in aid of charity projects running at this time.

As you read this issue of Roundabout, I am sure none of the brothers can claim not to have been urged to settle their membership fees for 2024/5. I am hoping that given another two more weeks we stop talking about levies/ membership fees and concentrate more on what we are here to do, things that we all proclaim at each council meeting when the four key brothers are invited to deliver their reports. I often try to prioritise Membership, Action, Youth, Welfare, Spirituality and Finance/admin, and with the Provincial team of officers try and work out which work we should focus on for the coming quarter. As I read the monthly council minutes that are regularly sent in to me, I am sufficiently satisfied that my message that ACTION is the ENGINE of each COUNCIL is largely being taken in by most of the nineteen councils in Province. The minutes are the instrument by which one can assess how well a council is doing, how many of the brothers are attending regular meetings, how far is the council being active in their own community, how recruitment is being tackled and news of brothers having been enrolled or elevated each month, how many councils are participating in the National children competitions, how many housebound brothers are being contacted and helped if needs be, how active is a council in its parish, while also keeping an eye out on membership numbers and brothers who had served so well over the years, but alas have passed away. I am keen to remind the Grand Knights and the brothers (who overseeing the work and activity of all councils in Province 41) that it is my duty, as unpopular as one can be from time-to-time, to point out better ways of doing things, while at the same time celebrating successes and achievements in the various councils.

I do not have a Provincial Membership officer, so in the next few months I will be exercising my 'Development' function.... Training sessions in the old language - by inviting brothers to a number of online 'Seminars' - training meetings. I am sure that such seminars are useful for brothers holding office, old and new. It is always useful to review our working practices and our strategies and debate how we can improve, increase or adapt these to be able to keep brothers interested and more efficient while at the same time help in achieving more successes each month.

I thank all the Grand Knights, their officers and brothers who attended the last Provincial Council meeting in Edmonton on 15th June. The next face-to-face Provincial council meeting will be in Northfields on 21st of September before we go to on-line meetings as winter bites, to spare brothers the travel and time—where they can attend the next two Provincial Meetings online - in the comfort of their homes. Hopefully we can get all of the councils to be represented.

I wish all those still going off on holiday, a safe journey and a good rest. ☉

**M**embership is a word that keeps coming up time-and-time again in all kinds of debate and discussion. At Provincial level it also includes Development - 'training' in old language.

What the word really means is, people who belong, brothers in a Council, team partners, colleagues, participants and dozens of other synonyms, but really in our Order it really refers to Brothers on the Books - on the database, in the council records.

It may sound a little cold, impersonal - devout of the 'FRATERNAL' spirit, that we the Knights are so proud of.

But are we so proud of our members in our council/order or are they just numbers ?

If it wasn't for our members, brothers in our council, brothers who come to meetings and those who may be housebound or sick, we would not be here at all, we would not have a Council, there would not be a Province and Head Office would not even exist. Yet do we really act in the way 'members' in our Council or Province are really intended to be? Do we treat our brother family siblings the same as we treat our Knight-brothers? One wonders !

Since Province41 was established Membership (actual brothers in council) has been top topic, the subject of many discussions, emails and listings. Great efforts continue to be made to review our listings, refresh our mind, linking a name with a face, some we may never have met, talked to or made an acquaintance with. Considerable progress has been made in listing the names and details of all the brothers in all our councils, but that is not enough. It is difficult to relate to someone who one had never even met, someone who never comes to meetings, may never have attended since some of our newer brothers joined. The responsibility of correcting this falls on the Membership Officer, but also on all the other brothers in council.

We talk about keeping contact, but do we ? With hand-on-heart, are the monthly council meeting minutes being sent to our housebound ? Some councils do regularly phone housebound brothers, but not all councils do that. Do we ring them, do we check if they need any help, do we ever check if their details are still correct, do we involve them in anything that we, the active brothers and the council are doing ? The Membership officer in council, should be passing more and more feedback to the council when he is invited to present his report. When he does, his report should be recorded - so that when the housebound brothers read the minutes, they can see that they are remembered.

Then there are the brothers, who are NOT housebound, yet never ever show up at meetings or any other activities organised by the council. These brothers are still council members, and a lot more can be done to ensure they are still brothers and not just names on a list. The minutes should always have an ABSENT heading with their names. In real terms if one invites a brother to come round to a get-together and he does not show up, the meeting ought to express some concern why that member has not shown up.

One absence may be understandable, something may have caused him to miss a meeting, he may have forgotten to send in an apology, someone ought to try and contact him and find out. If that brother-member fails to turn up a second time, the Grand Knight, the Membership Officer and the Welfare officer should surely do something about it and establish contact by phone, email or visit. One of the three officer should surely have something to report and minute in the next (third) meeting of absence. Hopefully that brother will understand how missed he'd been and will make an effort to attend the third council meeting. But what if he doesn't ? If the Membership officer or the Welfare officer had done their utmost and that brother could not be contacted by phone, email or post, it is time to start thinking that he has lost all interest and does not really want to continue his membership at all. That is when the Membership officer, with the Welfare officer and the Grand knight ought to start completing the M5 lapsation form. ●

Tribute to Brother John Lynn — our Provincial Action & Youth officer and Council 984 Thames Valley for his hard work on organising and managing St Edmund Campion's Pilgrimage and relic tour of the parishes - something he has been doing for over twenty years. Extract below from the Portsmouth Diocese newsletter which relates to one of the key stops of the Relic, at Lyford Grange Wantage in Oxfordshire two weeks ago. .... Quote ....

*John Lynn from the Knights of Columba shares news of this year's Lyford Grange Mass on **this Sunday, 23rd June at 4.00pm...***

This year Fr Liam Cummins MHM, parish priest of St Edmund Campion, Maidenhead is the main celebrant for the St Edmund Campion Pilgrimage Mass to be held at Lyford Grange, near Wantage OX12 0EQ on **Sunday 23rd June 2024 at 4.00pm**. It was at the Grange that the Jesuit priest Edmund Campion was captured before being shackled to a cart and dragged through the Thames Valley to London and put on trial. Campion was subsequently hanged, drawn and quartered with Alexander Briant and Ralph Sherwin on 1st December 1581.

This Mass is one of the main events in the annual St Edmund Campion Pilgrimage which follows Pope Paul VI's canonisation of St Edmund Campion as one of the Forty Martyrs of England and Wales. After the canonisation of the martyrs it was decided to carry on this act of worship for Christian Unity and Peace. The Knights of St Columba were asked to organise the annual pilgrimage with the Relic resting at churches overnight following as near as possible the route Campion took on his way from Lyford Grange in Oxfordshire where he was captured to Tyburn in London where he was put to death. Over 55 Masses are celebrated on this annual journey which this year started at Stonor on 5th May where there is a priest's hole and Campion famously hid his printing press and ends with the Tyburn Mass on Sunday 21st July.

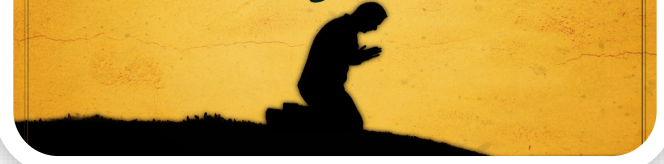
## JOB VACANCY

Brothers' deadline for paying in their annual dues to the Order by 30th June, has now passed. The end of June was set by Head Office and Province well in advance to enable councils to talk about ensuring they pay in their membership fees within the time set. Last October Supreme Council voted in favour of increasing the members' levy by two pounds to £62 per member per year.



Since the start of the financial year, in March, whenever councils met, everyone was made aware of the deadline and the provisions that existed for any brother who was financially pressed and could not meet his membership fee. Grand Knights and the Welfare Officers were urged to ensure that the necessary steps are taken so that no brother would be lapsed, simply because he was unable to pay his levy. All the Special Needs SW4a applications under the scheme should have been sent in to Head Office by the 24th June shown on the application form. If the Council officers failed to carry this out, they are complicit and seen to be contributing to some of their council brothers being lapsed.

Brothers who do not fall under the above 'Special Needs' classification should have paid in their levy to their council Finance Officer, to enable him to pay up the Council invoice to Head Office in time. If some of the brothers in council had not paid their dues after reminders etc, then the procedure leads to the lapsation process, completion of the M5 form and the brother is removed from the Council Good Standing Order [GSO] listing. In doing so the council can then amend the invoice to show the correct number of brothers and forward their invoice payment to Head Office accordingly. Failure to do this within the specified time could expose the council itself being suspended. Both the Council Grand Knight and his Finance officer, need to be aware that the penalty for failure to clear their HO invoice could result in the Council being suspended.

The deadline for the Provincial dues is also the end of June. The penalty for councils failing to pay their Provincial dues is £20 per month or part of month that the payment is not cleared. So hopefully Bro Desmond will be able to confirm that all councils had paid their provincial levy early in July.

It is sad that complying with these standard membership requirements causes loss of brothers, friction and penalties, and hopefully this year we will avoid having to be spending time and energy following up of non-payments instead of doing the work that we the Knights of St Columba are really here to be doing. ☺

It is essential that these forms are completed when applicable, as they contribute to the issue of your annual Head Office invoice every April. # June 8th Carlisle Report

## Report on Extra Ordinary Supreme Council Sat 8th June 2024 – Carlisle

There were 47 in attendance and able to vote. This included the full Board SK, 5 Past SKs, 4 Regional Directors. There were 3 PSKs notable to attend. The meeting started at 12.15, after the Angelus had been said in the Chapel. Bro Harry SK advised that the meeting would only be about Finance

matters. The standard Standing Orders were adopted. Bro Ron Lynch PSK continued to ask Bro Harry SK the Quorum number for the meeting. This was finally established at 30. The meeting did start in an atmosphere and with some friction in the air.

After amendments read by Bro Liam Rand (Prov 10) the adjusted Sept Supreme Council Mins were accepted. As were the December Zoom Mins. Bro Harry SK asked that the meeting be conducted in fraternity; and as a sign he apologised to Bro George Johnson. Bro Sean Smith started to present the Board's position on accounts and figures, transfers that had apparently not happened. Most of this had already been pre-circulated by emails. Bro Ron Lynch asked Bro Sean to be careful with his words and not to breach CBF laws Company law. Bro Sean's presentation was stopped and eventually the following proposals were made and adopted.

- 1) A Finance Director be appointed – agreed. Bro Tom Breen (an accountant) from Prov 12 Southwark agreed to take up this role. This was fully endorsed by all.
- 2) Have an Independent Audit of accounts from 2017 onwards. This was also agreed and the PSKs will recommend a firm to undertake this work. It will not be the present Auditors; who continue as at present.
- 3) All spending to stop from now and effectively reviewed via the two motions above. The recent £100k drawdown from the Benevolent Fund was to be ringfenced and not spent.
- 4) New Central Benevolent Fund Trustees appointed. These are Brothers that are not presently on the Board of Directors. It was agreed that these should be Bros Sean Mulligan (Past WS Director – Prov 12), Martin Cook (past Director 5 and Investment Manager – Prov 17), Mike Dean. The SK S/Director W will attend meetings but cannot vote on matters.
- 5) Bro Bertie Grogan was reinstated fully to his role of IPSK. He rejoined the top table.
- 6) A separate committee under Bro Ron Lynch (PSK) was appointed to look into Rules and Constitution amendments that would be needed in light of the various above appointments.

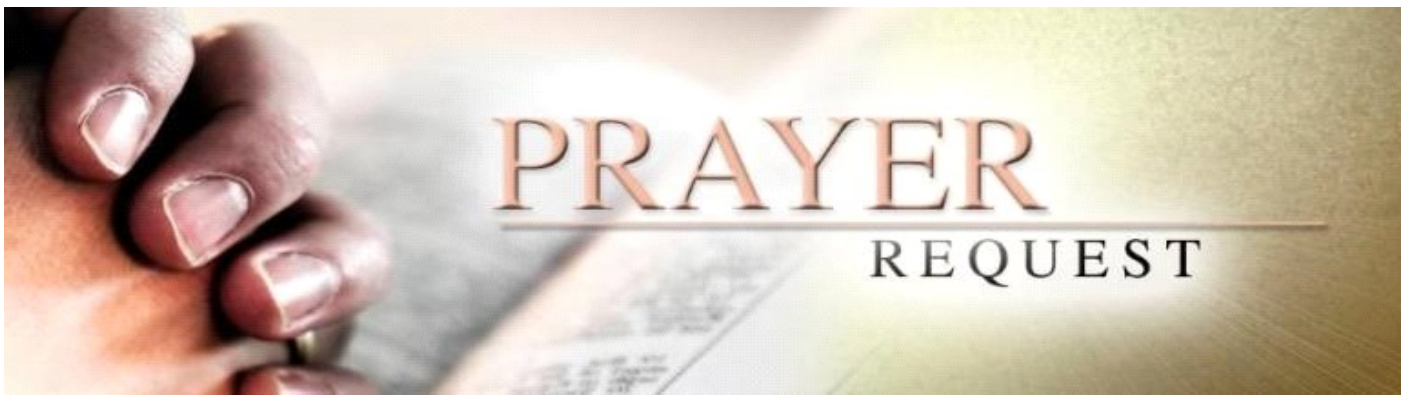
The following Bros would join this committee- Bro Richard Mitchell (Prov 9 Nottingham) George Johnson (Prov 10 Brentwood). Bros Richard Mitchell, Ron Lynch and Bertie Grogan all spoke about the sale of the old H/O Bungalow in Glasgow. This was a sale by Auction and was still to be confirmed by lawyers. Hence new owners not disclosed as yet. It was stated that a strip of land owned by the Diocese of Glasgow was not sold as part of this deal and hence all proceeds – after Capital Gains Tax – would be available to the Order.

It was asked that these funds be held in the Central Benevolent Fund and ringfenced for good works of the Order. It was also confirmed by a vote that the present Regional Directors would standdown at the October Supreme Co in Liverpool.

At the next October Supreme Council the 8 Regional Directors will be replaced by 4 new Supreme Councillors. The meeting closed at 2.10pm with normal prayers. A good meeting with great resolutions that brought us all back together in fraternity.

## Province 41 - Second Provincial meeting— EDMONTON.

On the 15th June - just a couple of weeks ago, we had our second Prov41 Provincial Council meeting. This time it was held in the north of London, as promised the meetings will alternate between north-and-south London during the summer season, and online during the winter season.

Our thanks to Edmonton Council 248 for hosting the meeting, and thanks also to Fr Philip Baptist our Provincial Chaplain, from Hampton Parish who travelled all the way to celebrate Mass at the start of the 11:00 meeting. We are also grateful to Bro Peter King and his Secretary Bro Paul Porter for preparing the hall, setting up the tables and chairs etc, as well as providing the tea/coffee and cakes after the meeting.

Eleven of our 19 Councils sent in a representative there were three apologies, and five councils were absent. The message to all councils, that the constitution of the Order specifies that ALL councils must be represented at Provincial meetings does not seem to have filtered through to our absent brothers. I was happy to meet several observers from the hosting council.

It was a good successful meeting which finished on time. We were able to provide those present with a summary of the Extraordinary Supreme Council meeting which was held at Carlisle on the 8th June. Our province was represented by Bro Jim Pugh Past Provincial Grand Knight P29. A summary of what was discussed and actions adopted to correct the outstanding financial issues of the Order were circulated to all councils present, and one other summary also included in this Roundabout issue. The Four prime officers delivered their reports based on the last Provincial officers meeting and the Provincial Committee meetings held 13th to 16th of May. The F & A officer reminded councils on the closing days for paying their Head Office and Provincial dues and repercussions arising from non-payment. Bro Des also reported on the lack of support for the Provincial 100-club and confirmed that this will now not go ahead. Bro Tony for M & Development, reminded councils that membership NO REPORT on council minutes was not acceptable as this meant that nothing had happened on recruitment since the last meeting. He urged councils to target more than one parish for recruitment, and the 18 - point action list that contributed to better recruiting. Bro Sam for S & W spoke about Special Needs [SW4a], the importance of following rituals in councils, information on pilgrimages in the next few weeks and plans for retreats in the coming months. Bro John Lynn for A & Y expressed regrets at the time being taken by HO in publishing winners of the recent Easter competitions. He spoke about the Edmund Campion pilgrim and urged councils in old Province 29 and 11 to join in on the relic tour of the parishes in the coming year. Fr Philip our Provincial chaplain spoke about importance of community action in parishes and how this would improve the profile of the Knights of St Columba and encourage recruitment.



Bro Tony Berkeley the Prov Grand Knight presented Bro Paul Porter [Secretary Council 248] with a Meritorious Medal in recognition of his hard work for the Knights in his parish, promoting recruitment and his hard work across all aspects of his council work. The next summer time Provincial Council meeting will be held south of London at Northfield on 21st of September, followed by winter season Provincial meetings which will be online ☺
